The ABA maintains the *National Public Registry of Audiology Preceptors™* for consumers, university programs and students to search for preceptors who hold the CH-AP certificate. By earning the CH-AP certificate, certificate holders agree to be publicly listed on the National Registry during their five-year valid certificate timeframe.

To earn the CH-AP certificate, a learner must:

- ❶ successfully complete, and pass the assessments of four training modules,
 - Module 1: Role of the Preceptor in a Clinical Environment
 - Module 2: Clinical Dynamics – Assessment and Performance
 - Module 3: Creating Effective Learning Programs
 - Module 4: Legal, Ethical and Professional Considerations
- ❷ maintain current licensure,
- ❸ sign the *Assessment-Based Certificate Holders Code of Ethics*.
